

# Concept Note: Robust Final Event

## Background

The Robust Consortium set out to conceptualize and critically examine what makes governance robust in times of turbulence and crisis. Through interdisciplinary research, the consortium explored how multi-level governance functions under stress, the drivers and barriers at both national and EU levels, and the often-messy realities of “networked localities” where crises are experienced most directly. It aimed not only to identify the key factors that enable robust governance but also to build a learning hub for mobilizing shared insights and advancing theory.

The project produced significant academic and practical outcomes, including new theoretical and methodological tools for supporting crisis governance, recommendations for enhancing the effectiveness and inclusiveness of governance arrangements, and insights into how political leadership can be strengthened while empowering citizens during turbulent times. The consortium generated a rich body of evidence on how governance systems adapt, innovate, and sometimes falter.

The consortium not only advances academic understanding of governance robustness but also provides actionable insights for policymakers and institutions tasked with crisis response.

## Objectives

The closing event will:

1. Present the consortium’s key findings across the five research work packages.
2. Situate AMR, hybrid warfare and climate disasters as a pressing governance crisis requiring urgent attention.
3. Explore the relevance of robust governance approaches to future crises.

A moderated panel bringing together Robust Horizon representatives and thematic experts to connect lessons from the project to AMR, hybrid warfare, and climate governance.
